- 1) Equipment Charges: Dual band ONT/Modem (modem will be of double antenna) will be provided by BSNL/ MTNL at the cost of Rs. 3000/- plus applicable GST.
- 2) No additional charges for registration, activation, installation, testing, migration, shifting, replacement of instrument/ONT, for new and already existing FTTH to be levied.
- 3) No CLIP charges and security deposit in FTTH.
- 4) No additional monthly service charge for ONT/Modem.
- 5) ISD/ Add on services only to be provided when such request is received through the nodal officer of Income Tax Department. No security deposit for ISD to be provided by Income Tax Department.
- 6) Any exceptional disconnection to be brought in notice of MTNL CO who has entered into the agreement with Income Tax Department and same to be done with the consent of Income Tax Department Nodal Officer.
- 7) GST extra as applicable.
- 8) Terms and Conditions apply.
